This fund is actively managed and has a global focus. Using active asset allocation in relation to the fund's level of risk, the fund manager seeks to maximise the total return primarily via exposure to equities, fixed income and alternative strategies. Hedge funds and currencies are examples of alternative strategies. The team also considers sustainability issues when selecting investments. When directly investing in equities and fixed income, the fund follows the fund company's strictest sustainability criteria in order to exclude companies that underperform in terms of sustainability. In terms of investing in SEB funds, the fund follows at a minimum - our fund company's high level of core criteria. These requirements are applied as much as possible to all SEB funds. When the fund invests in externally managed funds, we require the external fund manager to sign the United Nations Principles of Responsible Investment or to follow an equivalent sustainability framework. Since the fund invests in securities issued in currencies other than the base currency of the fund, the return may be affected by changes in the exchange rates.

INVESTMENT TEAM

The fund is managed by the Multi Management team at SEB Investement Management AB with Agneta Altino, Jonas Andersson, Micael Magnusson och Mark Rubin as portfolio managers. The team, based in Stockholm, focuses on structured allocation and selection processes when constructing portfolios with different risk levels.
